## **SUBJECT: Announcement of INS Elections 2022**

The Executive Committee (EC) of the Indian Nuclear Society has decided to conduct the INS Elections 2022 for the new Executive Committee for the term 2022-2024. In this regard, please note the following:

1. The EC has constituted the Election Committee and the same was approved in the Annual General Meeting held on 13-08-2022. The Election Committee is as per the following:
  - a. Shri N.K. Bansal, Returning Officer
  - b. Dr Ashok Kumar, Member
  - c. Dr A. Ramakrishna, Member
2. On the advice of EC, the AGM decided to hold the election in electronic mode (online). Subsequently, EC in consultation with Election Committee, hired an Agency to conduct the elections online. The Election Notice and Schedule would be sent by Shri N.K. Bansal, Returning Officer.
3. In this process, the members are to register as voters to cast their vote. The agency would send the [link](#) to the emails (max 2) and mobile numbers (max 2) available in INS Database. **On clicking the link, member would be asked to enter the Membership Number to view his Name, Emails and Mobile numbers. Member would be asked to choose only one email id and only one mobile number to register as the voter and this data only will be used at the time of online voting.** Two files are attached for the reference.
4. To facilitate the members to know their membership number, two files are attached here and would also be available to download from INS website [www.ins-india.org](http://www.ins-india.org).
  - i. Sorted on **First name** (initials) followed by Surname (last name)
  - ii. Sorted on **Surname** (last name) followed by First name (initials)
5. The members who don't receive the link message from the voting agency, are requested to contact INS Office through email [indiannuclearsociety@gmail.com](mailto:indiannuclearsociety@gmail.com) or by voice call at 022-25598327 or 022-25991097. The members' responses received till 31-10-2022 would be informed to the voting agency to include these additional names.
6. Once, the INS Election process is initiated by the Returning Officer, election related communication are to be addressed to Shri N.K. Bansal, Returning Officer by email at [ins.election.22@gmail.com](mailto:ins.election.22@gmail.com). The Membership related queries would be replied by INS Office.
7. *As there are many INS Members who have not provided or updated the email id and mobile numbers, it is desirable to get their data updated. To achieve it, all the members are requested to inform their friends through various google groups or WhatsApp groups.*
8. Please note the following important features of online election procedure:
  - a. The Voter Registration process will stop as per the schedule and will not continue during the period of voting.
  - b. Only one device (PC, Laptop, iPad, mobile, etc) could be used by the voter. Same device cannot be used by another voter. Devices connected to the same Wi-Fi, would be able to use only one device.
